- **Article 11**

The General Assembly consists of (all) members and, where practicable will be held once every two years. In addition, regional or local WBA assemblies may be convened with the authority of the Board of Directors.

The General Assembly elects the Board of Directors as a whole, the President-Elect to succeed the President in two years' time. They also approve the annual and financial report and the forecast.

- **Article 12**

WBA will be managed and administered by the Board of Directors.

The Board consists of President, President-Elect, Secretary, Treasurer and 2 (two) Executive Vice Presidents. For matters concerning a specific region the Board is expanded with a region representative, being the Regional Vice President.
